## TAEA ARTLOOK.....Legislative focus on "FLEXIBILITY"

There has been a great deal of activity in the 81<sup>st</sup> Legislative Session particularly in the area of Fine Arts. If you are interested in hearing more of the discussion, view the dialogue on the Texas Legislature Online web site <http://www.legis.state.tx.us/> .

Legislators are working on House & Senate Bill 3, the accountability bills for Texas graduates. Currently, Senate Bill 3 (vote 31-0) and House Bill 3 (vote 146-0) were passed by both the Senate and the House. These bills now move to the opposite chambers for a final vote.

Bill process but not finalized.... Although schools must continue to offer fine arts courses, as of 2011, one fine art credit will no longer be required for high school graduation. In addition, the Senate passed an amendment, sponsored by Senator Florence Shapiro, which will add four semesters of fine arts required for students in grades 6-8 as of 2011.

There is a great deal of discussion concerning these bills and the missing high school fine arts requirement for graduation. The legislators are trying to offer as much flexibility to the high school course offerings as possible. Yes, we are disappointed that the language of both 4X4+2 bills do not include the high school fine art requirement; however, students will have more course choices with 8 possible electives. If the bills pass and become law, there may be fewer students enrolled in PE, Technology and Communications courses. This means students would have the opportunity to select all 8 electives in the fine arts.

The additional required fine arts courses offered in grades 6-8 will set up a much broader foundation for students feeding into the high school fine arts courses.

# High School Division Mel Bashem

## **LARGE SCHOOL-SMALL SCHOOL SIMILARITIES**

Budget Issues, storage problems, student responsibility and motivation, time management - we shared this valuable information at the High School Division Meeting. Here are some of the results of our Budget Survey along with Stresses and Successes. A total of 61 schools participated in the survey; reflected is an average annual budget figure:

Number of schools – size – budget

26 – 5A – \$5,054.

16 – 4A – 6,931.

9 – 3 A - 3,000.

5 – 2A - 4,560.

3 – 1A - 2,000.

Private schools had budgets based on student fees and three 5A schools' budgets were determined by student art charges/fees.

All school budgets were handled by school board, principals, and/or the Fine Art Director.

In open discussion format, we shared some stresses and successes in studio organization. We all have problems with storage and supplies, but for every stress there was a success - 30 stresses and 25 successes. One big tip – get some clear plastic containers for storing material for each project. You can easily find the container complete with lesson plan and supplies. These containers are easily stacked in your storage area, or purchase some inexpensive plastic shelving and create extra space.

There were 27 stresses dealing with student responsibility, motivation and discipline balanced with 25 successes on the same issue. The best advice is to develop routines and relationships with your students. Let them know what you expect, be fair and consistent. Students are motivated when they know you respect them and appreciate their endeavors. Display their work, make announcements about awards, and let them know you are proud of them. Keep being positive and encouraging and the results will be the same.

## **TAEA SPRING 2009 REPORT**

Let's just say that November '08 seems like a year ago rather than the four months that have past. We were in the middle of electing a president, worried about a run away economy and just hoping we could all get through the year. I am sure most of our districts are tightening their belts, looking at how to eke one more dollar out of our budgets and preparing for a future of advocating for all of our programs. Our jobs are to put out fires, cut budgets where ever possible, be the cheerleader for our fine arts area and always ...always carry a positive attitude. When you look at the membership of over 3300 teachers, retired teachers and administrators, we are looking at the largest Art Education Association in the nation. That means we do have clout and we can make things happen. VASE, AP Studio Portfolios, International Baccalaureate, AP Art History and the numerous local scholarship events for our students are a recognition of the highest national standards being reached. These events proclaim that teaching in Texas continues to challenge students to achievements beyond some of our wildest dreams. Art Supervisors and Administrators play the vital role in the success of these Visual Arts programs. There must be a continuation of dialogue regarding a few subjects from the 2008 San Antonio conference. They start with the 4 X 4 and how to configure a schedule that is friendly to Fine Arts.

We have seen some ideas for some solutions but we encourage more discussion. Houston area supervisors and teachers are drafting a Texas Visual Arts Program for the Supervisors and Administrators to review for the next conference. Supervisors are monitoring facilities to make sure they are up to standards which include all safety procedures are implemented and followed. There was a call for the encouragement of more young artists to pursue a college degree and possibly an art education career. One of the biggest issues was budgets. There is a great deal of inequity in the amount of money designated to Visual Arts and even though that is public record there is still much disparity in how monies are doled out.

Texas is a huge state with a thousand districts. If you look at our Supervisors' contact list, you'll notice that there are only 140 names listed and some of those include both the Art Supervisor and the Fine Arts Director from the same district. That means that the 140 members of our group need to be a bigger voice for all of Texas. Let us be that bigger voice. In November, come to the conference ready to look at where we can make a difference in our own districts and influence those with out counterparts.



NAEA Delegates Assembly 2009  
Minneapolis, Minnesota  
Dr. Deborah B Reeve

Good morning!

I want to recognize the leadership legacy that many of you here today have helped to build – some over many years and through several eras and others more recently.

Together we are forging new paths bound by NAEA's historic core values and guided by an ambitious strategic plan. This gathering of NAEA leaders – of this Delegates Assembly - is a most important annual event in our organizational governance. As outlined in our Constitution/Bylaws – this DA is a recommending body for legislative and policy matters that include

- identifying and studying pertinent issues
- reviewing amendments to the Constitution/Bylaws
- reviewing member dues
- serving as liaison between the Board and state associations
- recommending Regional boundaries and/or additional Divisions
- reviewing Association policy on a regular basis

And here we are gathered in the beautiful city of Minneapolis – I don't know about you – but in my mind's eye – I've always seen Minneapolis sitting on one side of the Mississippi River and its "twin city," St Paul – sitting on the other side. Each having its own identity and personality – joined by the bridges over the river.

But on a whim - I took the google map tour – and my mental image was completely fragmented as I began to see that Minneapolis resides on both sides of the Mississippi – not just the west bank.

And further downstream, St Paul also flows across the river from its predominantly east-bank position to occupy territory on the west bank. In fact, for about two miles, east of the University of Minnesota, the line between the two cities runs rather indistinctly up through rail yards and industrial areas.

So, in reality, on the ground, the differences between the two cities aren't nearly so perceptible and the similarities are far more apparent – which I think in many ways is an apt analogy for NAEA membership.

We so often fall into our own boxes – elementary or middle or high school art teachers, university researchers/professors/scholars, museum education program directors, administrators.

But I know – and you know - that we have far more common ground and the great value of our annual conference is that it allows us to all come together in one grand community – exchanging a multitude of views

- holding tightly to what we know for sure
- gaining insights from unfamiliar and maybe even unsettling perspectives
- identifying new opportunities and resources...
- and enhancing our ability to work more productively when we are back within the boundaries of our roles at home.

It is hard to believe we inaugurated this new era almost two years ago in NYC where we celebrated NAEA's 60th anniversary and the legacy created by my predecessor, Dr. Thomas Hatfield, and the Boards who served during his tenure as Executive Director.

Since our gathering in NYC, we've been actively working to build new bridges and to forge new paths that help us work more effectively within the realities and uncertainties of today's world.

Leadership Guru Max Dupree said that the first responsibility of a leader is to define reality –

The last is to say thank you

And in between – the leader is a servant!

**I believe that each one of us is called to service – and we have been called to service during unprecedented times!**

As Bonnie said, I, too, am so very proud of each one of you! So proud of you for being here! Our registration numbers are strong – yes - we are a unique community – while our sister associations are reporting decreased attendance between 20 – 50% - we're less than 5% down in registrations! Thanks to the commitment and support of our exhibitors, we have a full exposition of new resources and materials for your classrooms! I also want to acknowledge the fruitful collaborative partnerships NAEA has forged over this past year:

- the Alliance for Young Writers and Artists
- Art21
- Digication
- Artsonia

- And corporate partners – Blick, SCAD, Davis and Crayola.

One of the great joys of my work as your Executive Director is the opportunity to get out and into the spaces and places where you do what you do every day! Your state conferences – your schools – your museums – your school district offices – your universities.

And – I know for certain - there has never been a more important time to be a visual arts educator and NAEA leader than today:

Never a more intriguing time.

Never a more challenging time.

Never a more rewarding time.

Together, over these past two years we've inaugurated a new era for NAEA that might be called the "synergy of purpose" era!

And this morning – I want to give you an update on the "State of our Union – the State of our Association":

- I want to briefly highlight the enormous progress that has been made - in a relatively short period of time – by each of us – working together – yes – synergy of purpose!
- I also want to outline what's just in front of us as we leave this collective space – the enormous responsibilities we must and we will assume – yes – synergy of purpose!

- Advisory Committee - Commitment to diversity of age, gender and ethnicity
- Divisions, Regions, Issues Groups, Fellows, Retired Art Educators, First Year Professionals, Students,

Organizational transformation takes time! Promoting continuous improvement, fostering innovation and nurturing community building takes time and is an ongoing process! But look at what we have accomplished in record time!! Working together – all toward a shared vision!!!

And now, let's look at what is in front of us – and I say this with a sense of great awe and with great urgency!

For generations, it seems that visual arts education has fueled a passionate debate about its rightful place. And that debate has impacted our roles and responses throughout our history.

**But I want to talk about today – we're living in a time of great uncertainty and great change everywhere we look. Old models of thinking and doing are collapsing and giving way to newer 21st century ways.**

Let me remind you that in today's world, under NCLB, the arts are, in fact, as defined by the Elementary and Secondary Education Act, considered a core subject. That was quite an accomplishment – but not enough! Not even close!

This is the year – after more than ten years (1997) – that the arts will be the focus of our nation's report card – the NAEP Report will be released in late May. And Congress has called for and committed funding for a second Fast Response Survey of arts teachers, classroom teachers and principals regarding the status and perceptions of the arts in education.

Some might say – that is great and it's about time and now we have an opportunity. And I say yes BUT - we have a monumental task in front of us!

It's not enough to continue to have these rigorous debates about arts education within our own professional community and espouse the value here and we REact to opportunities.

We must PROactively help lead and shape the conversation about teaching and learning in the 21st century! Yes – we must teach the nation why school-based instructional activities in the visual arts are essential to the learning process.

We know arts education has always been essential – but – perhaps today even more essential than ever given the negative impact of NCLB that has narrowed the curriculum and reduced the potential of many students to the point of being labeled by some as the “bubble generation.”

And we know - the visual arts are a non-negotiable when it comes to providing our students the sort of 21st century skills our education leaders and policymakers are now demanding.

We must remind the nation that every student deserves equal access to a balanced curriculum that includes the sciences, the arts and the humanities .....

**That the visual arts are essential to the learning process!**

Yes – this is a monumental task – and the National Art Education Association is resolved to helping lead the transformation of our education system, particularly with regard to student access to a balanced curriculum that includes the arts and is taught by highly qualified and certified teachers.

**Yes – a monumental task – are we up to it? I believe so!**

**And how you might ask how? How are we going to do this?**

First, the Elementary and Secondary Education Act declares the visual arts a part of the core K-12 curriculum and we must ensure the arts are treated as such. That starts with the classroom educator and continues with committed principals and district leadership who are supportive of the visual arts.

We do it by helping the nation to realize that as a core subject, the visual arts are a vital component of the learning community, with arts teachers receiving the same priority, the same professional development, and the same high expectations that are required of other core subject teachers in math, science and reading.

We do it by calling for every visual arts teacher to undergo a rigorous academic preparation and certification process, ensuring they have the discipline, knowledgebase, and pedagogy necessary to bring out the best in their students. Arts teachers should be held to the same standards, expectations, and measures as educators in other core subjects.

We do it by acknowledging the all important complementary values that teaching artists and museum educators bring to student learning and success.

We do it by boldly stating our rightful claim that visual arts teachers are at the forefront of delivering the 21st century skills needed by students to achieve and succeed.

We do it by helping business leaders see that the visual arts provide the ‘habits of mind’ that tomorrow’s high school graduates will need to perform in tomorrow’s jobs.

Finally, we do it by ensuring that visual arts teachers are provided the resources, professional development, and support that is required to drive student success measured through successful and rigorous state and federal assessment models.

Are we asking a lot? Absolutely.

Are we asking for too much? Absolutely not.

**We know the visual arts matter. We know that arts education impacts student learning in ways that can be measured.**

So this is our challenge – our opportunity – I believe – our responsibility – as the experts – the arts educators, scholars, researchers, practitioners and advocates, to teach the nation why school-based instructional activities in the visual arts are essential to the learning process.

**That is perhaps our legacy – synergy of purpose!**

And that is the work we will be engaged in over the weeks, months and years to come – as we develop opportunities for developing your capacity as leaders, champions and advocates for our nation’s youngest citizens and as position ourselves to help shape the conversations at every level and teach the nation why the visual arts are essential to the learning process!

I look forward to our time together over the next few days and I particularly look forward to all that will be accomplished in this Delegates Assembly over today and tomorrow and to celebrating with you at the conclusion of the 2009 DA tomorrow afternoon.

## Guidelines for Grant

1. The grant is earmarked for direct personal professional development, i.e., research, professional activities, creative work publications, etc.
2. The grant is generally to encourage new work, but work already in progress will be considered.
3. Funding will not be offered for projects geared solely to educational activities, supplies or materials, which should be funded by your institution.
4. Funding request for meals or books will not be honored.
5. The grant will be awarded to current TAEA members only.

## Guidelines for Grant Disbursement

1. Each application consists of a one page standard form available from TAEA or the TAEA President, plus support materials.
2. The grant will not exceed \$300.
3. Application deadline is June 30.
4. The grant will be awarded by the TAEA Executive Committee who are not eligible to apply.
5. A member may not receive more than one grant in a two-year period.
6. TAEA member receiving the grant will agree to present a workshop on the funded project/research/creative activity at the next fall conference.

## Guidelines for Grant Application Form

1. Section I. Fill out completely. Incomplete forms will not be reviewed.
2. Section II. Total amount not to exceed \$300.
3. Section III.
  - A. General Description of Project** - Give a brief description of what project entails.
  - B. Current Status of Project** - if project is underway, give a status report and what will be necessary to finish.
  - C. Anticipated Outcomes** - With completion of the project, will you be publishing, having an exhibit, lecturing, regarding your findings, etc?
  - D. Time Line** - Show your proposed time line with as specific dates as possible.
  - E. Itemized Budget** - Prepare a DETAILED LIST of expenses covering the requested amount of the grant. Be specific. List items and their costs.
  - F. Final Report** - A final report on your grant is due within one year after you receive your grant. Failure to meet this requirement line II-6 will preclude your further involvement in the TAEA Grant Program.
