



Rules and Guidelines

TASA/TASB and YAM Spring Exhibition



Entry Fee: Each entry will be assessed a fee at **\$10 per piece**. This fee helps to cover the cost of printing and returning artwork, mailing notifications and printing programs and certificates.

New for 2023-2024, all entries allotted will be based on the total number of enrolled students in your organization (Districts, Private Schools, Independent, Charter Schools, and Art Facilitators).

Throughout the rest of this document, the terminology of DISTRICT will refer to the organization as an entity and not necessarily an independent school district (ISD).

ONLINE REGISTRATION IS MANDATORY FOR TAEA SPONSORED EXHIBITS.

*Online registration: August 7, 2023 -- September 8, 2023 for TASA/TASB
November 6, 2023 – December 8, 2023 for YAM Spring Exhibition*

Registration of all artwork is done by ONE REPRESENTATIVE. If you are the representative for your district, please contact your colleagues so all artwork can be submitted together. After you have registered online, proofread ALL data entered. Check to make sure all names, addresses, and email address are entered correctly. Enter information using normal punctuation and capitalizations.

DO NOT USE ALL CAPS OR ALL LOWERCASE LETTERS WHEN ENTERING DATA. All artwork labels, mailing labels, certificates, and program contents are generated from the online entry typing.

Rules and Guidelines for Entries:

- Over 25,000 students, 8 (eight) entries: \$80.00
- 10,000 to 25,000 students, 6 (six) entries: \$60.00
- Less than 10,000 students, 3 (three) entries: \$30.00

Remember that participation in both YAM events is one of the many requirements for District of Distinction honors. Please note that YAM and DOD requirements are DIFFERENT. For specific questions and clarifications on District of Distinction, please visit www.taea.org.

Requirements:

- A teacher who is a current TAEA member may submit ONE artwork. Teachers who teach on more than one campus may submit one artwork from each campus.
- Students in grades Pre-K through 12 may participate.
- Individual entries only – **NO GROUP PROJECTS**
- 2-D flat work (if work is selected for the Spring Exhibition, **please fix charcoal and pastels**)
- **NEW FOR 2023-2024, for the first time ever, 3-D media, if selected, will be shipped or dropped off to be displayed in person.**
- **3-D media that is selected must fit into a 6"x12"x12" box weighing no more than 12lbs.**
- **Must be sturdy and able to stand alone without support.**
- **No sharp or protruding parts that would be dangerous to handle.**
- **All parts must be safely secured to a base and ready for immediate installation.**
- **NO WOOD or HEAVY CANVASES** – This artwork will not be hung as the display panels are made for lightweight work.
- **WHITE OR BLACK MAT ONLY**, no acetate, no frames or glass. Make sure all artwork is **securely matted (no thinner than 2 inches, no wider than 3 inches please) with a secure backing of cardboard or mat board.**
- Neat, high quality student work created within the calendar year should be sent.
- **NO COPY WORK or plagiarism. In keeping with the TEKS**, artwork must be original in thought, design, and execution. Copying or reproducing a published image is not original and will not be selected.
- Students' own photographs or student-directed photographs may be used as a source; **teacher's photographs should not be used.**

- Photographs that are painted or drawn over must be the student's original or student directed photograph, not one that has been published.
- Images should not be traced with the use of any projection device.
- **All entries must be created solely and exclusively by the student.**
- No one other than the artist of record may work directly on or manipulate any artwork entered in YAM or TASB; this includes parents, teachers/sponsors, private teachers, mentors, or other collaborators.
- **Artwork submitted for YAM or TASB may only be entered for one of these events.** If a work is shown, the same work may not be re-entered in the other event.
- Artwork content must be appropriate for the school, community and for young audiences.
- **Artwork with questionable content will be disqualified.**
- **Artwork not meeting these requirements will be disqualified.**

LABELING (For YAM Spring Exhibition Only):

- **Use the student artwork permission form in this book, and on www.taqa.org!**
- **Do not use older versions of this form. Please fill in the form electronically.**
- **Make 2 copies of the completed student artwork permission form.** Attach the **original** to the artwork and keep one for your records.
- Ship all district entries in a sturdy, reusable box. **Please use the smallest box possible that is appropriate for the size of entries for storage purposes a poster board box is ideal!**
- To prevent shipping damage, pack 2-D artwork in a flat cardboard box. You can tape the large envelope securely to the box or place it inside the box.
- In a large envelope, place the following:
 - One copy of each complete student artwork permission form
 - District Artwork Inventory List
 - Thumbnail Images of all artwork submitted
- No artwork will be mailed for TASA/TASB at all.
- **For the Spring Exhibition, artworks that are selected will be mailed using specific instructions given to the District Representative by the YAM VP.**
- All artwork and forms will be uploaded digitally to a folder shared with the District Representative.
- Once in the folder, the artworks will be juried and the selected pieces from each district will be notified so that the original artwork may be sent to the YAM VP - Angela Coffey.

TASA/TASB and YAM Spring Exhibition

Please submit one high quality image of student work along with electronically completed Student Artwork Permission Form and Student Artwork Release Form to the shared district folder that will be sent to the Representative who registered your district.

TASA/TASB Exhibit Only: Electronic submissions for exhibit selection. Once artwork has been juried and selected, prints of the artwork will be matted/mounted for display. You will NOT send the physical artwork. When submitting artwork images, see the 2-D and 3-D examples below. Please designate in the folder a description of top of the artwork if the image is not easily identifiable. You may also include an UP arrow indicating the display direction.

For both exhibits, please label artwork digital file: **District_LastFirst_Grade.jpg** (save it as a JPG); and please label the electronically completed permission slip: **District_LastFirst_Grade.pdf** (save the form as a PDF). You may also upload the student artwork release forms into the same folder as the PDFs.

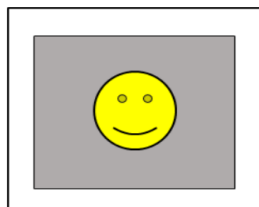
FRONT - 2-D ARTWORK

- WHITE OR BLACK mat (2"- 3" please)
- Not too heavy to hang with Velcro dots
- Loose cover sheet (to protect artwork)
- Do not tape over the forms

BACK - 2-D Artwork

- Sturdy backing (cardboard or mat board)
- Attach original Student/Parent Artwork Release Form
- Attach in the direction the art should hang OR draw an UP arrow indicating hanging direction

3-D ARTWORK

- 3-D media that is selected must fit into a 6"x 12"x 12" box weighing no more than 12 lbs.
- Must be sturdy and able to stand alone without support
- No sharp or protruding parts that would be dangerous to handle
- All parts must be safely secured to a base and ready for immediate installation
- Include original Student/Parent Artwork Release Form in box

- I agree to allow my art to be part of Texas Art Education Association’s exhibits. In doing so, I release TAEA and its agents from any and all responsibility in the event of loss or damage to my artwork.
- I agree to allow my art to be displayed, photographed and/or published for educational, non-profit, visual art publications and exhibitions, including TAEA’s online galleries and Texas Education Agency (TEA).
- If my artwork is selected as part of the Governor’s Gallery, I agree to allow it to be exhibited in the various business offices of the Governor and First Lady. I understand this will require my artwork to be in the possession of the TAEA from the conclusion of the State Youth Art Month Exhibit until the end of the following school year.

High School VASE, Junior VASE, and TEAM Events:

- I agree to abide by all TAEA Visual Art Scholastic Event (VASE) regulations and Code of Ethics.
- I agree to allow my artwork to be displayed and critiqued by selected jurors in conjunction with the TAEA Visual Arts Scholastic Event on both the Regional and High School State level. In doing so, I release TAEA and its agents from any and all responsibility in the event of loss or damage to my artwork.
- I agree to allow my artwork to be exhibited, displayed electronically on the TAEA and VASE Website, photographed, and/or published in educational, non-profit visual art publications and exhibitions chosen by the TAEA and waive any receipt or compensation for same.
- If my artwork is selected for High School VASE’s Gold Seal recognition, I agree to allow it to be exhibited at the TAEA Annual Conference. I understand this will require my artwork to be in the possession of the TAEA from the conclusion of the State Event until November of the following school year.
- Through High School VASE’s Gold Seal recognition, I understand that the image(s) submitted may be used in the development of a TAEA, Texas Commission on the Arts (TCA) and/or Texas Education Agency (TEA) initiative and may or may not be shown as part of a live exhibition, on-line, and/or appear in a reproduction series or book that may result. I understand that the materials may be utilized on-line and in publication form and that graphic images published within the World Wide Web are not fully protected under copyright laws. With this in mind, I release such images as have been submitted with the intention of exhibition and presentation at the facilities of the TEA and the TCA and other venues selected by the TAEA.
- I understand that it is my responsibility as the artist to secure written permission/consent, where possible, from any live model to use their image in an artwork and that this image may be used by the TAEA for live exhibition, online, and/or appear in a reproduction series or book that may result.
- Permission is also given to list the student's name, age and school facility of origin within the information used in the exhibition(s), on-line, and/or in any related newspaper article, newsletters and educational publications.
- This form serves as the VASE Student Agreement and Artwork Release Form as listed in VASE Program Rules & Policies.

This permission applies to all exhibits, contests, and events listed above for the current school year.
